The contractors are required to quote rates for each BOQ item given in the tender documents. They are also required to submit complete prequalification documents as listed below:-

The contractors are required to submit documents in two separate sealed envelopes, clearly marked the **Prequalification Documents** and the other **PRICEDTENDERS**.

The **PRE-QUALIFICATION DOCUMENTS** shall include:

1. Full name organization, address, of its Head Office and Branch Office, Phone & Fax numbers and contact person.
2. Type of firm whether limited company, partnership or proprietorship alongwith copies for evidence, Memorandum & Articles of Association and paid up Capital/partnership Deed with shares of partners and Registration Certificate copies (showing number of years in construction field/business).
3. Record of firm's experience on similar nature of works executed during the last 5 years with successful completion alongwith copies of work order from clients.
4. Details of works in hand, their names, contract value, client, date of start and expected completion time alongwith copies of work order from clients.
5. List of Equipments, form work, scaffolding and T&P owned by the contractor.
6. Name of firm's Directors/partners, Engineers and other professional staff with their qualification and experience including their PEC registration number and CVs.
7. Copy of the registration of contractor with the Pakistan Engineering Council with proof of upto date fee paid (minimum PEC registration category C-6)
8. Proof of current registration with various Government /Semi Government Departments/Organizations.
9. Certificate from a scheduled Bank giving contractor's current financial stability and bank statement for last 3 years.

10. Certified/audited annual accounts for the last 3 years showing profit and loss.
11. Registration with income tax authorities/National Tax Number certificate alongwith latest income tax, clearance certificate and return filed with income tax department.
12. Detail of Litigation or Arbitration or black listing if any, If none, an affidavit on stamp paper that firm is not involved in the past Arbitration and has never black-listed be submitted

THE PRICE TENDERS SHALL BE submitted on tender documents in sealed envelope.

- The tender documents can be obtained from the office of our Consultants M/s. Sarfraz Ahmed & Associates, 25-D/1, Gulberg-III, Lahore during office hours from **17.05 2016** upto **27.05.2016** on payment **Rs.10000/- per tender**. No tender shall be issued on the fixed date for opening of the tenders.
- The completed 2 envelopes for submission of documents one for pre-qualification and the other sealed Price Tenders must reach in the office of General Manager, Chairman Senior Tender Committee PTV Centre 21 Abbot Road Lahore at 11.30hours on 22.06.2016. and will be opened on the same day at 12.00 hours in presence of tenderers or their authorized representative who may like to be present.
- The second set of envelopes regarding Price Tenders of only pre-qualified bidders have been opened on a date to be informed later by letter after scrutiny.
- The earnest money required to be enclosed with the Price Tender shall be equal to 2% (two percent) of the tender amount of the works in the form of a Call Deposit or Pay Order, Bank Draft issued by a scheduled Bank of Pakistan infavour of GM, PTV-Centre Lahore.
- Incomplete submission of documents shall not be considered/entertained.
- PTV shall have the sole discretion/right to accept or reject any or all bids.
