- 4. Quotations separately marked as (Technical & Financial) must reach AJK TV Office on or before 08.10.2022 and will be opened (Technical proposal only) at 01:00PM on same day.
- 5. Bidders are required to mention price and applicable GST on the quotation.
- 6. The quotation must be accompanied by earnest money @ 3% of the total estimated value of the bid in the form of Call Deposit/ Bank Draft (refundable) drawn in favor of AJK TV Centre Muzaffarabad. The earnest money of successful tender will be retained and that of other bidders will be returned.
- 7. Quotation must be valid for a period of 90 days from the date of opening.

- Mention date of delivery of Camcorders/accessories, extension of date & time in supply of goods will not be allowed.
- Sales Tax and income Tax Numbers must be indicated on quotation. Copies of valid Registration (GST) and (NTN) should be affixed with the bidding documents.
